ARTICLES OF INCORPORATION  
OF

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to the formation of a corporation under the laws of the State of Florida.

ARTICLE I  
Name

Term of Existence

**ARTICLE VI**

**Initial Registered Office, Agent and Corporation**

The initial street address in Florida of the initial registered office of this Corporation is 304 S. **Cumulative Voting**

Notice must be given to the President of this Corporation not less than twenty-four (24) hours prior to the time set for the holding of the shareholders' meeting for the election of directors that


**ARTICLE X**


