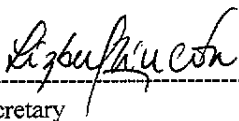

OF

ARTICLE ONE

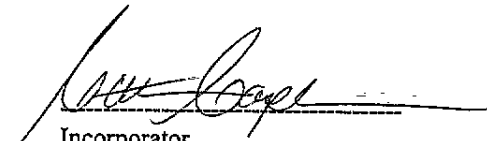
