ARTICLE I

The corporate name shall be,

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

- 1. The number of shares of authorized capital stock of the corporation shall be One Hundred (100) shares of common stock with a nominal par value of One Dollar (\$1.00) each.
