# ARTICLES OF INCORPORATION SUSAN C. JANNOU, D.P.M., P.A.

The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract and is legally authorized and licensed to practice as a physician in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I - NAME

The name of this corporation is SUSAN C. JANNOU, D.P.M., P.A.

#### ARTICLE II - DURATION

0.9 OCT 18 11 7:58 This Corporation shall commence its existence immediately upon the filing of the Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved in accordance with the laws of the State of Florida.

### ARTICLE III - PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business are as follows:

- To engage in the practice of podiatry medicine as a professional service corporation and to 1. provide services incident thereto.
