**ARTICLES OF INCORPORATION FOR STARNET TRANSPORTATION, INC.**

*The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I**

The name of the corporation shall be StarNet Transportation, Inc.

**ARTICLE II**

The duration of the corporation of StarNet Transportation, Inc., shall be perpetual.

**ARTICLE III**

StarNet Transportation, Inc., will be in the business of providing access to medical transportation services for interested individuals and entities.

**ARTICLE IV**

Pursuant to non-compete agreements signed by the incorporator, StarNet Transportation, Inc., shall not provide its services of transporting medical patients for medical care or treatment, within the tri-county area of Monroe, Dade, or Broward County, Florida for a period of three years from the date of July 19, 1999. Shall said non-compete agreements be discarded, breached by the other party, found to be illegal, null and/or void prior to the end of said three year period, StarNet Transportation, Inc., may elect to become a service provider for the above-mentioned tri-county area.
