1. The name of the corporation is JUGUEHY, INC. (the "Corporation").
2. The Corporation was formed in the State of Florida on October 19, 1999, under Charter No. P99000092558.
3. None of the shares of the Corporation have been issued and the Corporation has not commenced business.
