ARTICLES OF INCORPORATION
OF
YOUNG HOME CONSULTANTS, INC.

Article I - Name

The name of this corporation is YOUNG HOME CONSULTANTS, INC.

Article II - Principal Place of Business

This corporation shall exist for a perpetual period.


Article VIII - Initial Registered Office and Agent SECRETARY OF STATE
