ARTICLES OF INCORPORATION
OF
HAMMOND EGGHEADS WEB DESIGN STUDIOS, INC.

ARTICLE 1. NAME.

The name of the Corporation is HAMMOND EGGHEADS WEB DESIGN STUDIOS, INC. ---

ARTICLE II. DURATION.

This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE.

This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK.

This Corporation is authorized to issue 1,000 shares of one dollar (\$1.00) par value common stock.

ARTICLE V. MANAGEMENT.

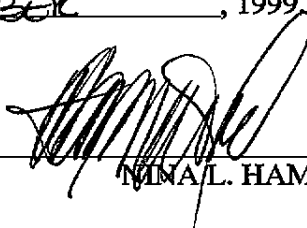
ARTICLE VIII. PRE-EMPTIVE RIGHTS.
