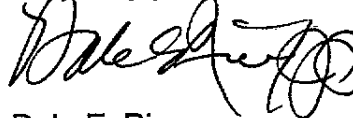

ARTICLES OF INCORPORATION
OF
SECURITY VILLAGE MISSIONS, INC.
A CORPORATION NOT FOR PROFIT

I, the undersigned, with other persons being desirous of forming
a corporation for religious purposes do agree to the following:

ARTICLE ONE

The name of the corporation shall be: SECURITY VILLAGE MISSIONS,
INC., and it is to be initially located in Crestview, Okaloosa County, Florida.

ARTICLE TWO

The general nature and object of the corporation shall be to assist local
churches in fulfilling the message, mission and vision of the Bible; by partnering
with local churches to design, develop, administer and manage facilities, services
and supports to and for the poor and needy, to acquire, hold, use, mortgage,
lease, sell or otherwise encumber and dispose of real and personal property; and
to do all other matters and things whatsoever necessary, convenient, useful, or
incidental to the carrying out of the objects and purposes of the corporation and
that are permissible for a non-profit corporation in Florida.

ARTICLE THREE

The members shall elect the directors with the method of election to be provided for in the By-Laws.

ARTICLE FOUR

The corporation shall have perpetual existence.

ARTICLE FIVE

The name and place of residence of the incorporator of these Articles is as follows:

ARTICLE SEVEN

The following shall serve as officers until the election called for in the By-Laws:

ARTICLE EIGHT

No person, firm, or corporation shall ever receive any dividends or profits from the undertaking of this corporation; and, upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses

of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, and none of the assets will be distributed to any member, officer or director of this corporation.

ARTICLE NINE

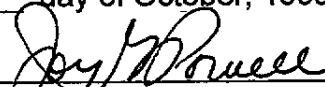
