ARTICLE I-NAME

ARTICLE II-DURATION

This corporation shall exist perpetually, commencing on the
day of signing.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting
any and all lawful business relating to that of a Real
Estate Association, including acting as Trustee.

ARTICLE IV-CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of no
par value common stock.
