ARTICLE XI.





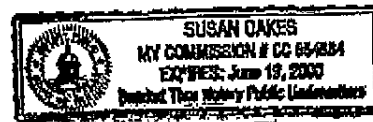
