ARTICLES OF INCORPORATION

of

PRO TOP NAILS & SKIN CARE, INC.

ARTICLE I - Name

The name of the corporation shall be:

PRO TOP NAILS & SKIN CARE, INC.

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following: Nail and skin care related services.

ARTICLE IV - Capital Stock

This corporation is authorized to issue One Thousand (1,000) shares of Ten Cents (.10) par value common stock which shall be designated "Common Shares."
