ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such a corporation:

Article I

Name of Corporation: Jay Jalaram of Homestead, Inc.

Article IV

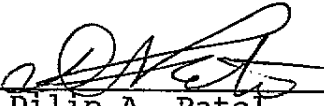

The corporation elects to have preemptive rights.

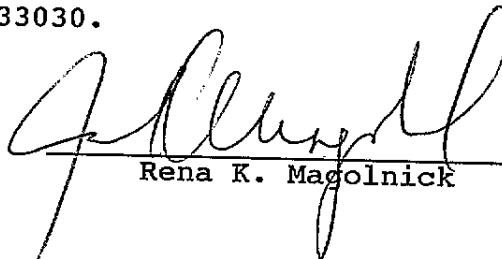
