

ARTICLES OF INCORPORATION OF



O'NEILL ADVERTISING, INC.

The undersigned hereby executes the following for the purpose of forming a corporation under the General Corporation Act of the State of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I Name and Address

The name of the corporation shall be O'NEILL ADVERTISING, INC. The street and mailing address of the corporation is: 19321 U.S. Highway 19 North, Suite 500, Clearwater, Florida 33764

ARTICLE II Existence

This corporation shall have perpetual existence unless sooner dissolved by law.

ARTICLE III Purpose

The authorized capital stock of the corporation shall be 1,000 shares of common stock at no par value. These provisions as to preemptive rights shall not be amended, rescinded, or otherwise altered in any manner except by unanimous vote of the shareholders.
