

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the laws of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation is **FISHERMEN'S VILLAGE CAPITAL**MANAGEMENT, INC.

ARTICLE II

This corporation is organized for the sole purpose of acting as the General partner of Fishermen's Village - Punta Gorda, LTD., a Florida Limited Partnership; and any and all acts incidental and necessary to act as General Partner of the Limited Partnership.
