The business will conduct its operations in the following geographical area: Sarasota and Manatee County's. State of Florida.

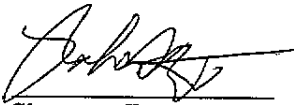

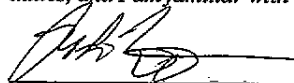
