In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is: Joseph B. Nichols, P.A.

ARTICLE II

The existence of the corporation shall begin on: October 19, 1999

ARTICLE III

The street address of the principal office of the Corporation is: 5135 Cantoura Drive, Orlando, Florida 32810.

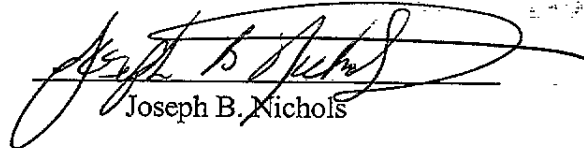
ARTICLE VIII

The specific nature of the business shall be Realtor.

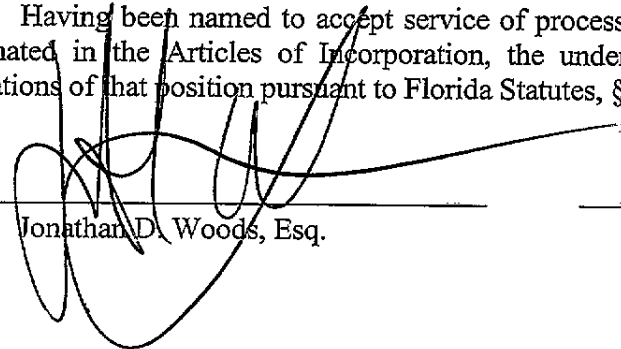
