The undersigned incorporator, for the purpose of forming a professional association under the Professional Services Corporation Act, hereby adopts the following Articles of Incorporation.

Article I Name and Duration

Article V Shareholder Restrictions

No one other than an individual who is duly licensed or legally authorized to render medical services in the State of Florida may own stock of this professional association.
