ARTICLES OF INCORPORATION

of

MILLENIUM GROUP PRODUCTIONS, INC.



The undersigned incorporator, being a natural person competent to contract, subscribes to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I. NAME

The name of this corporation is MILLENIUM GROUP PRODUCTIONS, INC. and its principal place of business is 8235 Wellsmere Circle, Orlando, F1. 32835

II PURPOSE

The purpose for which the corporation is organized to produce, direct, or consult in the making of movies, collect revenues and royalties from movies and any other lawful purpose.

III. DURATION

The term of existence of the corporation is perpetual.
