ARTICLE I. NAME

The name of this corporation shall be James A. Reese, P.A.

ARTICLE II. DURATION

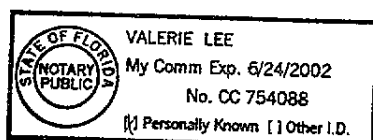


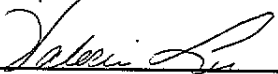
