ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Stromco, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 5297 N.W. 112th Terrace Coral Springs, Florida 33076

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
