ARTICLES OF INCORPORATION

ARTICLE I. NAME

99 OUT 22 PH W. 38 The name of this corporation is MENACHO REALTY, INC., whose address is 2309 West Main Street, Leesburg, Florida 34748.

ARTICLE II. COMMENCEMENT OF EXISTENCE

This corporation shall begin its existence on the date of filing of these Articles of Incorporation.

ARTICLE III. DURATION

The term of existence of the corporation is perpetual.
