The name of the corporation is Scenic Lo Bama, Inc.

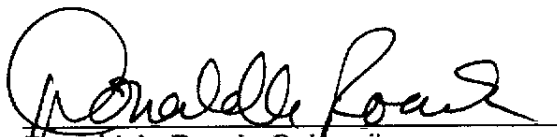
ARTICLE NINE - BY-LAWS

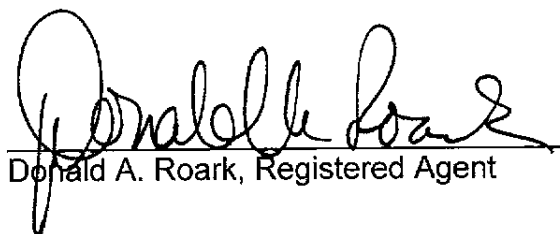
