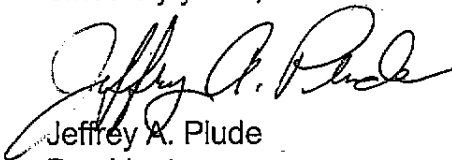

# **ARTICLES OF INCORPORATION OF *MACHINE CONCEPTS, INC.***

## ***ARTICLE I. NAME***

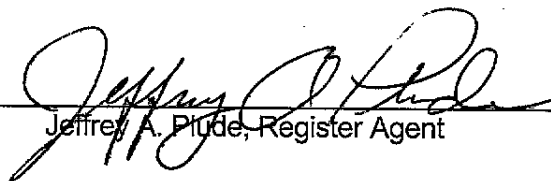
