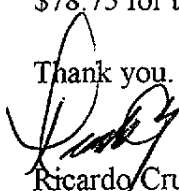

Article I

The name of this corporation is RAM Sports, Inc.

Article II

This corporation shall have perpetual existence, and shall commence upon the signing and acknowledging of these articles.

Articles III

This corporation is authorized to issue 100 (one hundred) shares of \$1 (one dollar) par value common stock.

Article IV

The street address of the initial registered agent of this corporation is 6680 South West 41<sup>st</sup> Place, Davie, Florida, 33314 and the name of the initial registered agent of this corporation at the address is Marguerite Mogul Cruz.

Article V

Except as otherwise provided for by law, the entire voting power for the election of directions and for all other purposes shall be vested exclusively in the shareholders of the outstanding common stock.

Article VI

Every shareholder, upon sale for cash, note, or the equivalent in I.O.U. form for comparable services to be performed to the corporation, of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article VII

The corporation is organized for the purpose of transacting any and all lawful businesses.

Article VIII

This corporation shall have one director initially. The number of directors may increase from time to time by the By-Laws but shall never be less than 1 (one) and shall always be an odd number. The name and address of the initial director of this corporation is as follows:

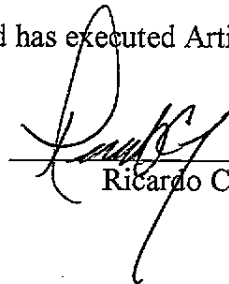
Article XI

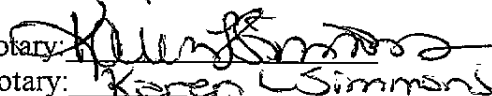
