# Articles of Incorporation

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

## Article I Name

The name of the corporation shall be Accelerated Business Systems Incorporated.

## Article II Principal office

The principal place of business in the state of Florida where its principal office is to be located and mailing address of this corporation shall be:

## Article III Shares

The number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) all of which shall be common shares without par value.
