The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is **BAYSHORE MINI-STORAGE, INC.** The principal place of business of the corporation is 3061 Van Buren Avenue, Naples, Florida 34112. The mailing address of the corporation is 3061 Van Buren Avenue, Naples, Florida 34112.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

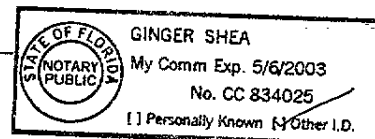
