ARTICLES OF INCORPORATION

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is The D-Z, Inc., and the principal address is 1610 Nebraska Avenue, Palm Harbor, Florida, 34683.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is 1610 Nebraska Avenue, Palm Harbor, Florida, 34683. The name of its registered agent at such address is Matt Dillon.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

ARTICLE IV - AUTHORIZED SHARES OF STOCK


