**ARTICLES OF INCORPORATION**  
**OF**  
**CHRISTOPHER CAMPBELL, O.D., P.A.**  
**A Florida Corporation**

(Pursuant to Chapter 607 and 621, Florida Statutes)

The undersigned persons have associated themselves for the purpose of forming a corporation under the laws of Florida and adopt the following Articles of Incorporation.

1. **Name.** The name of this corporation is CHRISTOPHER CAMPBELL, O.D., P.A.. The period of duration shall be perpetual.
2. **Purpose and Powers.** This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.
3. **Initial Business.** The general nature of the business proposed to be transacted initially by the corporation, at any place within the United States, is to practice the profession of optometry and generally to do all acts reasonable and necessary for the furtherance of such business.
4. **Authorized Capital.** The Corporation Shall have the authority to issue 750 shares of common stock. The par value of the stock is \$ 1.00.
