ARTICLE I.

NAME

The name of this Corporation shall be: PATRIOT SOUTHERN INC.

ARTICLE II.

PURPOSE

This Corporation is organized for the purpose of buying, improving, lease, and to sell real property, which purpose shall include any other business permitted under the laws of the State of Florida.

ARTICLE III.

CAPITAL STOCK

This Corporation is authorized to issue 1000 shares of common stock, with \$1.00 par value.

ARTICLE IV.

TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V.

INITIAL REGISTERED OFFICE AND AGENT

DISTRIBUTION OF LOSSES

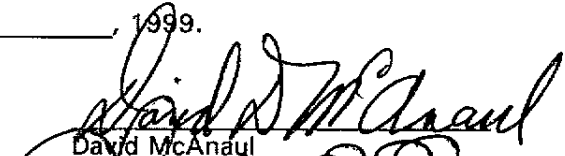
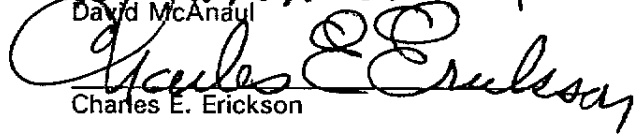
