**ARTICLES OF INCORPORATION OF  
J.M.K. CONCERTS, INC.**

The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I  
NAME**

The name of the Corporation is **J.M.K. CONCERTS, INC.**

**ARTICLE II
