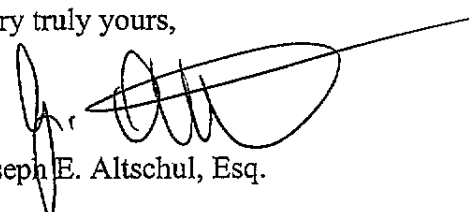

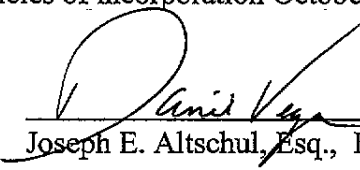

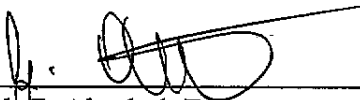
**Designation and Acceptance of Registered Agent
