**ARTICLES OF INCORPORATION  
OF  
TERESITA Y. DEGAMO M.D., P.A.**

The undersigned incorporator(s) for the purpose of forming a Professional Association under the Florida Professional Service Corporation Act, hereby adopt the following Articles of Incorporation.

**ARTICLE 1: NAME**

The name of the Professional Association shall be Teresita Y. Degamo M.D., P.A.

**ARTICLE 2: PRINCIPAL PLACE OF BUSINESS**
