We, the undersigned subscribers, hereby come before the state of Florida for the purpose of becoming a corporation. This corporation is organized by and under the provisions of For-Profit Corporation's statutes of the State of Florida.

ARTICLE I

GENERAL NATURE OF BUSINESS

This corporation may act as a general and specialized Supply company for businesses, non-profit organization, and governments that operate seagoing vessels and on land entities. Supplies consist of general commodities, food, beverages, produce, hardware, parts, equipment, vehicles, and communications devices.
