ARTICLES OF INCORPORATION

OF

CORTEZ PROFESSIONAL CONSULTANTS, INC.

ARTICLE I - NAME

The name of the corporation is CORTEZ PROFESSIONAL CONSULTANTS, INC.

ARTICLE II - DURATION
