Articles of Incorporation of

Tuscany Tiles of Southwest Florida, Inc.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address

The name of the Corporation is Tuscany Tiles of Southwest Florida, Inc. The principal office and the mailing address of the Corporation is 5567 Taylor Road, Unit 1, Naples, Florida 34109.

Article 2.
Duration

The duration of the Corporation is perpetual.

Article 3. Purpose

The general purposes for which the Corporation is organized are the following:
