THE UNDERSIGNED, for the purpose of forming a Corporation under the Florida General Corporation Act Chapter 607 does hereby adopt the following Articles of Incorporation.

### ARTICLE I - NAME

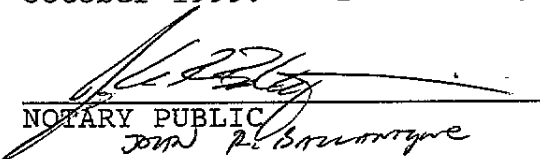
