ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be Dentist to Dentist Online Inc. The principal place of business shall be 1411 North Flagler Drive #5200, West Palm Beach, Florida 33401.

ARTICLE II. NATURE OF BUSINESS


