

The captioned Taxpayer received a notice requesting a \$550 (i.e., Late) Payment for their 2000 UBR filing.

To begin with, they have no record of having ever received an earlier mailing for this report. But they weren't expecting it, either.

Although they incorporated in October, 1999, there was absolutely no activity, of any sort, until mid-January, 2000. When the entity was formed there was a question as to whether or not it would ever be activated.
