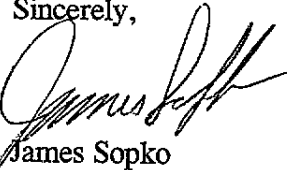

**ARTICLE I**

**NAME**

The name of this corporation shall be: R.J. MARINE SERVICES, INC.

**ARTICLE II**

**TERM OF EXISTENCE**

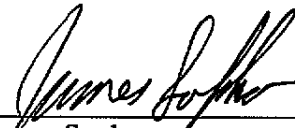
