On or about September 22nd, 2000 we received a notice of administrative dissolution or revocation for our corporation, (Redoc, Inc), along with an application for reinstatement. The notice indicated the annual requirement for Florida corporations to file an annual report/uniform business report and that notice of such requirement was sent to us along with the forms. The notice also indicted that a second notice was sent by June 9, 2000 informing us that revocation/dissolution would take place if the annual report was not filed by Sept 13, 2000.

I am 100% sure that these notices were sent. I am also 100% sure that they were not delivered to our mailbox. We live in a townhouse section of a subdivision that has a central location for mailboxes for 32 families. Frequently, (at least 25% of the time), our mail, as well as the mail of our neighbors, is put in the wrong box. Most times the neighbor receiving the erroneous mail delivers it to the correct unit however many times this is not the case, especially if the neighbor does not recognize the name on the letter. Most of our neighbors do not know the name of our company and I am quite sure the letters were discarded. We also have to be careful about our monthly billing statements since they sometimes do not make it into our hands. This is a little easier to monitor because we know when our statements usually arrive and can make arrangements on the phone. In the case of the report in question however, I must admit to inefficiency on my part because I did not know about the requirement and therefore did not know enough to inquire as to the absence of the notices. This is due to having formed our corporation only last October. This is not an excuse but only an explanation.

I talked with one of your representatives on Oct 17th and he suggested I send the reinstatement form in with a letter of explanation and a request to waive the reinstatement fee, along with a check to cover the annual report fee and corporate supplemental fee, (\$150.00). Please consider my explanation and I ask that the reinstatement fee be waived. Enclosed is our check for \$150.00 and our request that you reinstate Redoc. Inc. Thank you very much.
