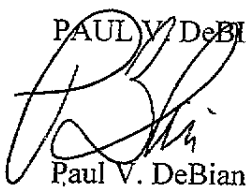

ARTICLE I-Name

The name of this corporation is: NET RESULTS OF SOUTH FLORIDA, INC.

ARTICLE II-Duration

This corporation shall exist perpetually.

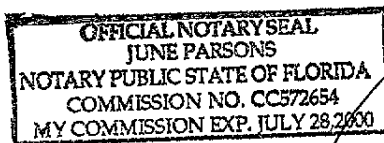
