The undersigned subscriber to these Articles of Incorporation, a natural person competent to the contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation shall be MASTERSCAPE, INC., a Florida corporation.

#### ARTICLE II - NATURE OF BUSINESS
