ARTICLES OF INCORPORATION
OF
BIALEK ENTERPRISES, INC.

These Articles of Incorporation are made and acknowledged by the undersigned Incorporator for the purpose of creating a domestic corporation for profit in accordance with §607.0202 *Florida Statutes*.

ARTICLE I

The corporate name of the corporation shall be BIALEK ENTERPRISES, INC.

ARTICLE II

The address of the principal business office of the corporation shall be 812 Ocean Boulevard, Pompano Beach, Florida 33062. The mailing address shall be the same.

ARTICLE III

The corporation is organized to engage in any lawful act or activity for which corporations may be organized under the provisions of the Florida General Corporation Act. Without limitation of the foregoing, it is anticipated that the initial business of the corporation will be operation of a motel.

ARTICLE IV

The amount of the total authorized capital stock of this corporation is One Thousand Dollars (\$1,000.00) divided into one thousand (1,000) shares of common stock of the same class. Each share shall have a par value equal to One Dollar (\$1.00). All shares shall confer upon the owners thereof the same rights. No preemptive rights are granted to shareholders.

ARTICLE V

The name of the incorporator is Stanley Bialek. The address of the Incorporator is 813 Briney Avenue, Pompano Beach, Florida 33062.

ARTICLE VI

The number of Directors of the corporation shall be one (1); however, the number of Directors may be changed by amendment of the By-Laws of the corporation. Cumulative voting for Directors shall not be permitted.

ARTICLE VII

The corporation shall have perpetual existence, which existence shall commence upon the date these Articles of Incorporation are signed by the Incorporator, as indicated below.

ARTICLE VIII

The street address of the initial registered office of the corporation shall be 812 Ocean Boulevard, Pompano Beach, Florida 33062. The name of the initial registered agent of the corporation at that office is Danuta B. Presutti. A written acceptance of such office in accordance with §607.0501(3) *Florida Statutes* accompanies these Articles.

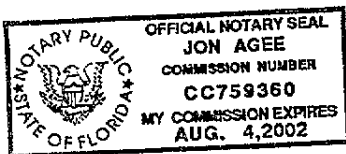
