ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is LOS RANCHOS STEAK, SEAFOOD AND CANTINA, INC.

ARTICLE II

This existence of this corporation shall be perpetual unless dissolved according to Florida law. In the event of dissolution of this corporation, all remaining assets of the corporation shall be transferred and delivered according to Florida law.

ARTICLE III

This corporation is organized for the purpose of erecting, constructing, establishing, purchasing, leasing and otherwise acquiring, and holding, using, supplying, servicing, maintaining, operating, selling, and otherwise disposing of restaurants, cafes, cafeterias, grills, bars, cocktail lounges, banquet halls, catering

establishments, and other eating and drinking places of every kind and description, and generally conducting the business of restaurateurs, caterers, and purveyors, suppliers, preparers, servers, and dispensers of food and drink; and engaging in all activities, rendering all services, and buying, selling, using, handling, and dealing in all fixtures, machinery, apparatus, equipment, accessories, materials, products and merchandise incidental thereto, or of use therein; as well as transacting any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

ARTICLE V

ARTICLE VI

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

The corporation shall be managed by a Board of Directors. The number of Directors, method of election and the method of removal of Directors shall be as provided in the By-laws of the corporation.
