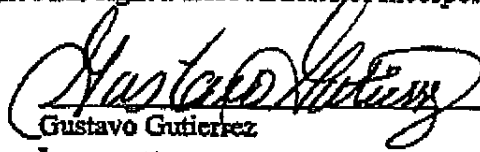
ARTICLE NINE

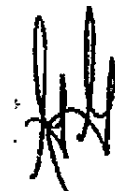
