

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

NAME AND ADDRESS

The name of the corporation is Cornerstone Consumable Supplies Inc., and its initial address is 2503 W 72nd Street, Hialeah, Fl 33016.

ARTICLE TWO

CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of: Purchasing And Re-selling Medical Supplies.

2.
