ARTICLES OF INCORPORATION

EFFECTIVE DATE

ARTICLE I

The name of the corporation is Italian Foods Corporation (hereinafter called the "Corporation").

ARTICLE II

The address of the principle office and the mailing address of the Corporation is 5014 NW 71st Place, Gainesville, Florida 32653 c/o Mr. Andrea Tosolini.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or person authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of the persons entitled to vote on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

ARTICLE V

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws.
