## ARTICLE I - CORPORATE NAME

The name of the Corporation is: ON SCREEN, INC.

# ARTICLE II - NATURE OF BUSINESS AND POWERS

The principal nature of the business to be transacted by this corporation is to engage any business permitted under the Laws of the state of Florida, and especially producing television shows, interviews and entertainment programing.
