The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

- 1. The name of the corporation is: PETS TO GO, INC.
- 2. The general nature and purpose of business to be transacted, promoted and carried on by the corporation are as follows:
